1. Facilities, Parks and Open Spaces

1.a CBS Soccer Association - Correspondence

This item was deferred for discussion at the upcoming Committee of the Whole.

1.b Correspondence - All Saints Softball Field

The Committee discussed this correspondence in length. As the Town does not own this field, they requested staff respond to the resident, outlining the existing mitigative measures for potential safety concerns, such as netting, and signage for appropriate use.

1.c Recreation Complex Shutdown - Update

There has been a delay in the roofing work being completed as part of the Recreation Complex shutdown. This is due to the significant amount of rain experienced during the month of August, which caused ten working days to be lost.

The new anticipated date of re-opening will be Monday, September 19. All programs and groups that were anticipated to start before these dates will be notified, and birthday party rentals that were booked will either be re-scheduled or refunded.

This was provided for the information of the Committee.

1.d Community Park - Entrance Way

Potential options for entryway signage to the Community Park were discussed by the Committee, including the entry point on Bishops Road and the playground entrance.

As there are no funds currently available for this expense, the Committee concurred to defer this item until funds are available, with a goal to have entryway signage installed prior to the next summer season opening. They also requested staff research associated costs and concepts.

2. Programs and Special Events

2.a Santa Claus Parade and Tree Lighting Ceremony

The Committee discussed the Santa Claus Parade and Tree Lighting Ceremony dates, and concurred to proceed with both on December 3, 2022.

2.b Light Walk

The Committee discussed the locations and duration for this year's Light Walk display. The Committee concurred to continue to partner with Manuels River on this event, pending their continued contribution. The lights will be lit in the middle of December, and will remain lit until old Christmas Day, January 6, 2023.

3. Procurement

3.a Community Park Rubber Matting - Approval to Award - Ratification

In preparation for the Community Park playground rubber matting installation, staff recently met with contractor representatives onsite. Representatives advised subgrade granular work is needed due to exposure to weather elements overtime.

The Town contacted GCA to provide a cost estimate for work as directed by the contractor. A quote for an upset limit of \$56,977.56 was received. GCA also confirmed work can start immediately, and within a timeframe before matting installers are onsite.

On August 23, 2022, Council was briefed on the item, and approved the award to GCA as quoted.

The following ratification was tabled for approval:

Be it so resolved that approval is given to award the supply and installation of granular material for the Community Park playground area to GCA at an upset cost of \$56,977.56. Funds are available in the Open Space Fund.
