### 1. Business Development

# 1.a 50th Anniversary Business Recognition

The Committee concurred to issue a call for business and commercial properties owners to contact the Town as part of a recognition initiative for 2023 related to the Town's 50th Anniversary. The Committee requested a business listing be emailed to Council.

#### 1.b Traffic Counts

The Committee discussed traffic counts captured in 2022 in the west end of town. The information will be used to supplement investment attraction marketing efforts and will be placed on the website.

# 2.a Newcomer Info Portal

The Committee reviewed a draft page for the website containing targeted information for newcomers to the town. The Committee were happy with the draft version and suggested a couple of minor edits which staff will complete prior to launch in the coming weeks.

## 2.b Sustainability Hub

The Director provided an update on the Sustainability Hub and discussed the development of a monthly bulletin to commence in the new year. The Committee concurred.

### 2.c Backyard Compost Program Survey

The Committee concurred with staff initiating a digital engagement campaign with residents to gauge interest in a Backyard Composting Program anticipated to be released by the MMSB in the coming weeks.

### 2.d Heritage Grant Issues

Annually, the Town provides a Heritage Grant Program to which municipally designated heritage properties can apply for general upkeep. Applications are reviewed and approval letters are sent to each organization. Included in the approval letter is the requirement that work must be completed by registered businesses within the municipality where they are headquartered and all necessary permits from the Town much be in please for the work taking place. Receipts for work completed are submitted, a site visit takes place and a review for compliance with program guidelines is conducted. As part of the compliance review, there were instances where property owners did not follow the guidelines set out in the approval letter.

Following a discussion, the Committee concurred that program guidelines must be adhered to no later than December 31, 2022. It is the intention of staff to work closely with the heritage property owners to achieve compliance. Should compliance within the guidelines not be achieved, the grant may not be reimbursed the full amount.

#### 2.e Ocean Glen Neighbourhood Garden

The Committee reviewed, and concurred with, draft correspondence and an online form be circulated to property owners of Ocean Glen Subdivision in relation to the future of their neighbourhood garden. The information will be circulated to property owners by mail in the coming weeks. The outcome of the engagement will be reported back to the Committee.
