
4. Discussion Items


4.a Ambulance Services

Mayor Bent advised that a letter was sent along to the Department of Health and Community Services to express our concerns with the lack of ambulance services in Conception Bay South. He advised that he met this morning with the Minster of Health and Community Services and his staff to elaborate on those concerns with the lack of services.

The Mayor requested the Department to conduct a review of the ambulatory services provided to the Town. He also requested the Town be provided with the opportunity to provide input on the ongoing province wide review of ambulance services.

He advised that the Minister was very aware of our concerns and committed to continuing to work with us in a collaborative manner.







4.d Award of RFP 23-04 Supply, Delivery, Installation & Maintenance of a Two-Way Radio Repeater System at the Parsons Clubhouse, Seal Cove

RFP 23-04 has closed and the Fire Chief has reviewed the submitted bid. The decision to award the RFP contract to HiTech Communications was based on their ability to meet the specifications outlined in the tender documentation, quality of product, customer service and price. The money for this expenditure will be taken from the Communications Budget Line, 01-107-5000-8025
