

An Order was issued on March 24, 2023, requiring the repair or demolition of the dwelling situated at 24 Jones Lane, Conception Bay South.

On January 31, 2024, a Municipal Enforcement Officer confirmed the house was demolished and the property is now in compliance with Town Regulations.


An updated Terms of Reference was attached for the information of the Committee.
